SAFE BIKE RIDING TIPS

- ✓ Always wear a bike helmet
- ✓ Always keep your reflective vest with you in case you find yourself in a situation where you have to wear it
- ✓ Wear light or bright-colour clothing so that motorists can see you
- ✓ Check your breaks before riding
- ✓ Ride on the right-hand side of the road
- ✓ Obey traffic signs and signals
- ✓ Stop and check traffic before riding into a street
- ✓ Raise your arm before turning to signal to other road users that you are about to make the turn

THEFT: In case of theft please declare the stolen bicycle to the Service-Desk@cern.ch and inform the Car Pool.
